OPEN MEETING

Chair opened meeting, welcomed new members Mr. Belton and Mrs. Shearin and called roll noting a quorum is present. Mr. Butler noted the way the EDA operates regarding grants/loans.

APPROVAL OF MINUTES

Mr. Cannaday made the motion to approve the minutes; duly seconded by Mr. Baumgardner. Motion carried 7-0.

FINANCIALS

Mr. Butler noted the financial report (on file in County Admin office) and noted that \$788,204.54 is the current balance – discussed payments and revenue received – also noted that Angela Biram's place is now open and seems to be doing good – EDA members would like to attend her Grand Opening. Mrs. Hash made the motion to approve the financials; duly seconded by Mr. Cannaday. Motion carried 7-0.

OLD BUSINESS

 ARS Discussion – Mr. Butler explained the ARS program and bringing blighted areas back into habitable dwellings for Grayson County Citizens.

NEW BUSINESS

- EDA Grant Application Steve/Kit Marshall Mr./Mrs. Marshall came to the EDA with a new endeavor called the Acorn House plans are to turn it into a vacation rental to include local amenities, noting that they currently own two (2) more commercial buildings seeking a \$12K grant to meet their timeline of one (1) year or less to completion Mr./Mrs. Marshall noted that since they are both involved in the Town of Independence, feel it's not appropriate to ask the Independence Town IDA for any kind of monetary help. Mrs. Cornett explained the Tourism Zone and noted that the Marshalls have applied for the Tourism Zone and incentives not every Air BnB is approved.
- Chamber of Commerce Dues Discussion took place on the EDA paying the \$8K dues made the motion to approve the EDA to pay the dues and become more involved with the Chamber; duly seconded by Mrs. Hash. Motion carried 4-0 with Mr. Baumgardner, Mr. Belton, and Mrs. Shearin all abstained.
- High School Welding Center Mr. Butler explained the \$100K request from Mr. Kelly Wilmore, Grayson County School Superintendent, to put a welding center in the high school discussion took place regarding the ask and how to mold the agreement Mr. Wilmore will be invited to the next meeting.
- Meeting Time EDA members will look at their options on meeting date and times.

EXECUTIVE SESSION

Mrs. Hash made the motion to go into closed session for discussions relating to the acquisition or disposition of real property pursuant to §2.2-3711(A)(4) of the Code of Virginia involving ARS; duly seconded by Mr. Baumgardner. Motion carried 7-0.
