## IN RE: Call to Order:

Staff updated members of the board with new legislative updates related to the adoption of changes to section 15.2-2308.1 Boards of zoning appeals, ex parte communication, proceedings, and 15.2-2204 Advertisement requirements. Changes were made to allow public access to public body meetings through electronic communication means, including telephone or videoconferencing, and may provide the public with the opportunity to comment through the use of such electronic communication. Regarding advertising requirements, staff explained the new requirements for advertising have received issues and complaints from areas. In southwest VA, the time frame is unrealistic as not every paper runs a daily newspaper causing an issue in meeting the new time frame requirements. It is understood this will be addressed in the next general assembly session this year.
